I'll be coming up from sheep captures in Gardiner, so best for me is if we can meet at the intersection of Hwy 89 south and the Mill Creek Rd? If you take exit 333 in Livingston, turn left at the light on hwy 89 south and just continue south for about 15 miles. There's a forest service access sign for the Mill Creek Rd on your left as you approach the intersection, and the Mill Creek Trading Post is a funky log building on the right. Let's meet in the parking area for the Mill Creek Trading Post at 2:45. If this sounds complicated and we run the risk of losing you along the way, let me know and I can leave captures a few minutes earlier and meet up with you at the exit in town.

If Glenn or other GWA members are planning to attend, please let me know as I would like to communicate that to others.

I left a message at the Redfield ranch letting them know and inviting them to attend the meeting, have not yet heard anything back. I thought it appropriate to include them as they are just south of the Mill Creek Rd and could potentially be affected by hazing/hunting of elk north of the road. I would be hesitant to invite Druska to this particular meeting, as this opens a can of worms for other landowners throughout the valley that we should invite if we extend attendance beyond those in the immediate area of concern. The landowners who are affected are anxious to have a focused meeting to discuss what we are going to do as the daily commingling is an immediate crisis to be addressed, and I worry that expanding the group will expand the discussion into the larger issues which could result in a less focused and longer discussion. I would support a more general meeting for the Paradise Valley to discuss the larger issues and have some discussion on where to implement working groups and who to involve etc if folks are interested. If you think it important to include Druska I'll certainly defer to your judgment.

One more item came up as I write... Got a call from Deanne Durgan (wife of county commissioner Jim Durgan). They have 300-600 head of elk that have gotten into their haystacks and are crossing over the fence into the cattle pasture, commingling with cattle. I will go visit with them tomorrow afternoon and have a look.
