Secondary opportunities include boating, swimming, picnicking, wildlife observation and natural and cultural preservation.

A tract of land in the NE1/4 of the NE1/4 of Section 36, Township 1 South, Range 5 East, P.M.M., Gallatin County, Montana, and more particularly described as follows:

Beginning at the E1/16 corner of Sections 25 and 36; Thence along the north line of said Section 36, N89°36'20°E, a distance of 324 feet to the centerline of the East Gallatin River and the northwest corner of a tract of land described in FM 3, Plat 671; Thence along said centerline and the west line of said tract S07°36'54°E, a distance of 135 feet; Thence S89°36'20°W, a distance of 341 feet to a point on the E1/16 line of said Section 36; Thence along said E1/16 line N 0°04'18° W, a distance of 133 feet to the true point of beginning.


